#### **ORDER**

Re: Establishment of District Court Management Personnel Advisory Committee

Pursuant to Article 3, Section 1 of the Kansas Constitution, the Supreme Court hereby creates the District Court Management Personnel Advisory Committee (committee) for a two year period beginning December 5, 2019. The members of the committee are charged with serving in an advisory capacity to the Supreme Court in its examination of the district court administrative management personnel structure and management personnel classifications for employees. The committee will assist by responding to requests for input including the following:

- 1. Providing information on existing management structure and processes
- 2. Identifying and sharing challenges and issues regarding existing management structure and processes
- 3. Contributing ideas on improvements to make the management structure as effective and efficient as possible
- 4. Providing feedback on existing and possible new management structure and management classifications
- 5. Drawing from individual experiences and knowledge in exercising judgment but seeking the best outcome for the state as a whole
- 6. Assisting with resulting transitions, if any, that the Supreme Court may implement as a result of its examination
- 7. Working towards the best possible outcomes to benefit the State and staying within fiscal limitations
