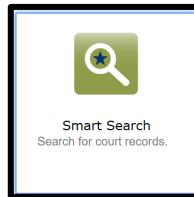


## Appellate Public Portal Smart Search

*A public webpage available on any browser. (Chrome is preferred).*



- Users must **Register** to perform a Smart Search.
  - **Note:** If a user has registered to use the Kansas District Court Public Access Portal, there is no need to register for the Appellate Portal. The same username and password can be used.



- A **Record (Case) Number or Name** is required for all searches.
- Select the **?** to display search tips.

Smart Search \*Required

Search Criteria ?

Type the record number in the search criteria field.

For a precision search, click Advanced Filtering Options to expand additional search fields.

To search for a case by a business name, click Advanced Filtering Options, navigate to the General Options section, and select "Business Name" from the Filter by Search Type drop-down list. Type the business name in the search field above, and click Submit.

Advanced Filtering Options -

- Check the **I'm not a robot** reCAPTCHA box and verify before selecting **Submit**.
- Select **Advanced Filtering Options** to reveal additional case search options.

## Advanced Filtering Options:

### General Options

- **Filter by Location** – Appellate Courts is the only location option.
- **Filter by Search Type** – Options include Smart Search, Attorney bar number, attorney name, business name, case cross reference number, case number, citation number, nickname and party name.

### Party Search Criteria

- **Search by** – Party name, Business name, Nickname or Sounds Like. Business Name must be checked if searching for a business.
- **FBI Number, SO Number, or Booking Number** are additional party search criteria fields.

### Case Search Criteria

- **Filter by Case Type** – Use the drop-down to select a case category.
- **Filter by Case Status** – Use the drop-down to select a case status.
- Select **File Date Start** and **File Date End** to enter a file date range.
